Deputy Governor General Report From DGG Dr. Laura Smith

- The 2021 GBOA was held in Plymouth September 9-12th.
 - ♦ Highlights of the special events that occurred:
 - * Pilgrim Hall Museum is creating a 20-panel tapestry to commemorate 400 years of the Pilgrim and Patuxet Indian story. Four panels are finished and were on display.
 - * A Pilgrim Progress was held on Saturday followed by a program in the Meetinghouse.
 - * A Garden reception was held at the Mayflower Society House on Saturday to dedicate the new William Bradford statue.
 - * A dinner to commemorate the 400th anniversary of the first Thanks-giving was held on Friday and Saturday night.
 - ♦ The Heritage week breakfast is April 13, 2022 at the Army Navy Club in Washington DC.
 - The 2022 GBOA is in Minneapolis, MN.
- A new Executive Director of the GSMD was announced-Mark Schmidt.
- The Mayflower Society house is closed this year so it can get some much-needed repairs.
- Meetinghouse.
 - ♦ The exterior work is complete and one bay of the sanctuary has been restored
 - To date 4.8 million has been raised of the 12 million to fully restore the meeting-house and create an education center and endowment to sustain the Meetinghouse long term.
- Silver books project.
 - 14 new/revised books in progress and new editions will list both the Mayflower passenger and his wife.

 - ♦ The eventual goal is to have silver books document down to Generation 7 and naming the 8th generation.
 - ♦ The John Howland Mayflower Families books are out of print and can't be republished because the society does not own the rights to the books. The society is starting from scratch and re-researching those Howland children and going to do silver books for each child in the JHMF series.

Deputy Governor General Report Continue

- ♦ The project has a Facebook page and an email <u>silverbooks@themayflowersociety.org</u>.
- The technology committee has created a new website for the Society that is up and running www.TheMayflowerSociety.org.
- Three amendments, all changing the bi-laws to allow for electronic meetings were approved by the GBOA to be voted on at Congress in 2023.
- Indiana AG and Charter Mayflower Guard member Chuck Provost, who has also been DGG and treasurer of our society for 10 years was recognized for his outstanding years of service to our Indiana Society.



The Indiana Society of Mayflower Descendants has honored Historian Dr. Laura Smith with a brick on the Garden Walkway (photo), in appreciation for all of her contributions to the ISMD as well as the General Society. A nomination from an appreciative member spurred our Board to honor her. Our Indiana Society enthusiastically agreed that such a distinction was well deserved.

From an early age Laura was interested in genealogy and a project in middle school began a life-long quest to document her ancestry.

She became a member of the Indiana Mayflower Society on December 26, 2012 with 12 Mayflower passengers in her lineage. She was voted onto the Board of Assistants in the spring of 2013 and that fall Laura became Indiana's State Historian. With her mother Pam as Assistant Historian, she has facilitated approximately 150 Mayflower memberships. She was Indiana's AG from 2017 to 2020 and is the current DGG. In 2019 Laura became Deputy Governor and has filled in as the Recording Secretary since the spring of 2020. She also worked diligently with former Society Governor Linda McGlothlin to update Indiana's online database, which includes all of the 1600+ Society members since 1916! Laura also created a slideshow at the 2016 GBOA to commemorate the 100th anniversary of the Indiana Society. She is a full time veterinarian at Cityway Animal Clinics in downtown Indianapolis. In her spare time, she is also a member of the First Indiana Company Jamestowne Society, Indiana Pioneers, the National Society Colonial Dames of America and DAR; and participates in Revolutionary War reenactments.

Gifts That Pay Now

Appreciated Securities: The gift of appreciated securities is most often in the form of a common stock or mutual funds. This kind of a gift is a valuable way to benefit the Indiana Society of Mayflower Descendants (ISMD) and for you to receive a tax benefit based on the fair-market value of your assets.

Real Estate: Real Estate can be deeded outright to a nonprofit organization or left by bequest. The irrevocable gift of property may provide an immediate deduction and help you to avoid capital gains. Please consult a qualified financial advisor to determine if this gift will work for you.

Life Insurance: You can make a gift of a policy or buy a policy making the Indiana Society of Mayflower Descendants the owner and beneficiary

Gifts That Pay Income

Charitable Gift Annuity (CGA): The gift annuity is an irrevocable gift of cash or securities where you can receive a fixed income for life. At termination of the trust, the nonprofit beneficiary receives the residual value of the annuity. Due to the complexity of this type of gift, please consult a financial advisor.

Charitable Remainder Trust (CRT): This trust allows the remainder of the assets (whatever assets remain after all other terms and conditions have been fulfilled) are transferred to a nonprofit organization.

Charitable Lead Trust: The reverse of a CRT, this trust provides a steady income stream to a non-profit over a set period of years. After these years, the remainder of the trust can be passed from the estate to heirs with very little or no tax.

Gifts That Pay Later

Wills and Bequests: A gift that enables you to retain the asset during your life and passes to beneficiaries when you no longer require the asset. You can make a nonprofit such as the ISMD a beneficiary or contingent beneficiary of this asset.

Revocable "Living" Trust: This is created by transferring title of property to a trustee under an arrangement where the trustee manages the trust property for the benefit of the trustor's purposes.

Retirement Plans: Retirement plans can sometimes be the heaviest-taxed assets in an estate. By naming the ISMD as a beneficiary or part-beneficiary, you can avoid taxation on all or part of your retirement plan.
